High Octane Agility, LLC Event Protocol during COVID-19

This is subject to change before or after closing date. Final updates will be sent in your final entry confirmation email.

1. If you have had COVID-19, you may not attend unless you have had a negative test. If you have been exposed to COVID-19, you may not attend within 14 days since exposure.
2. Masks must be worn at all briefings, walk-thrus and course builds.
3. If fully vaccinated (2+ weeks after final vaccination shot), you do not need to wear a mask if practicing proper social distancing, with the exceptions of # 2 above. If you are not fully vaccinated, a mask must be worn at all times when indoors (except while running in ring) and/or social distancing is not possible outdoors.
4. Masks do not need to be worn while running in the ring. Masks should be removed after entering the ring, remain on your persons, and put back on prior to leaving the ring.
5. We will be monitoring to make sure we are in compliance with indoor gathering restrictions currently specified by the PA Department of Health and may ask you to leave the building at any time. We may also ask you to move apart if you are not maintaining proper social distancing.
6. Warm up jump will be located outside.
7. Crating will NOT be allowed inside the building
8. Running orders, courses and scores will be posted online at <https://k9trialservices.com>.
9. Weather permitting, arena doors will be open to aid in ventilation.
10. There will be no hospitality (beverage and food will not be supplied or available to participants)
11. Exhibitors must bring their own mask. Masks will not be available.
12. Hand sanitizer and disinfectant will be available, but it is highly recommended that exhibitors bring their own.
13. A port-a-pot will be used for exhibitors. As this will be an area of high traffic, please sanitize your hands before and after use.
14. Walkthroughs will be limited to 20 people maximum. Please try to maintain a six foot distance during all walkthroughs. Masks must be worn during walkthroughs.
15. Upon entering the ring, exhibitors will place leash/toy in a basket and the basket will be moved to the exit.
16. Ribbons will be self-serve. Please sanitize your hands before touching the ribbon container.
17. We will be following the Travel Guidelines as issued by the PA Department of Health. Current guidelines can be found by clicking the following link
