Trial Site Rules

- This event is being held at Orchard Hills which is located on private property and is NOT open to the public outside of event hours. Waiting on the driveway or on Church Street prior to the facility opening is not allowed.
- The premises are closed within 30 minutes of the last run or when the show committee leaves for the evening (whichever is earlier) and all
 competitors must exit by that time.
- Please use the designated potty area to the right of the red building in the first pen behind the propane tank and clean up after your dogs.
- You may use the sheep pens directly next to the potty area to run your dog. There may be sheep in one of the pens. Please DO NOT open
 the gates or allow your dog to enter the pens with sheep.
- There is a \$10 potty fine for any dogs pottying in any area other than the designated area, ESPECIALLY on or around either of the buildings! There is also a \$10 potty fine for any dog pottying inside the building.
- Obey the speed limit when driving on North Church Street. Police have been known to issue tickets for speeding.
- Absolutely no competitors/dogs allowed on the property to the left as you are coming up the long driveway.
- No celebratory balloons are permitted on the premises. These have caused damage to the fans inside the buildings in the past.
- Trial site opens @ 7A and closes 30 minutes after the last run or when the show committee leaves (whichever is earlier).

Keystone Agility Club Event Protocol during COVID-19



This is subject to change as State regulations are updated. Final updates will be sent as they are made.

- 1. If you have had COVID-19, you may not attend unless you have had a negative test. If you have been exposed to COVID-19, you may not attend within 14 days since exposure.
- 2. Temperature of each person will be taken with a no contact thermometer. Anyone with a temperature above 100.4 will be asked to leave and will not be able to participate.
- 3. There will be limited spectator chairs available with wipes. Please wipe chair after your use. If a chair is not available, you may not be in the spectating area.
- 4. We will be monitoring the number of people inside the arena at any one time to make sure we are in compliance with PA DOH guidelines and may ask you to leave the building at any time. We may also ask you to move apart if you are not maintaining proper social distancing.
- 5. Participant chairs are not permitted in the spectator area.
- 6. Warm up jump will be located outside.
- 7. Crating will NOT be allowed inside the building.
- 8. Running orders, courses and scores will be posted online at www.k9trialservices.com
- 9. No guests or unentered persons allowed on the premises without permission from the trial manager/secretary.
- 10. Exhibitors may NOT touch any equipment unless s/he is a worker.
- 11. Weather permitting, arena doors will be open to aid in ventilation.
- 12. There will be no hospitality (beverage and food will not be supplied or available to participants)
- 13. Masks must be worn at all times on the premises.
- 14. Exhibitors must bring their own mask. Masks will not be available.
- 15. Hand sanitizer and disinfectant will be available, but it is highly recommended that exhibitors bring their own
- 16. The bathroom doors will be propped "open" to minimize touching of handles. Only 2 people are permitted in the bathrooms at a time, one person in the stalls and 1 person at the sink. Please maintain a six foot distance while waiting in line to enter the bathrooms.
- 17. The hose and bathrooms seem to be the places where you will be "touching" things that are used frequently. Please sanitize and /or wash your hands in these instances.
- 18. Walkthroughs may be split to maintain compliance with state guidelines. Please try to maintain a six foot distance during all walkthroughs. Masks must be worn during walkthroughs.
- 19. Upon entering the ring, exhibitors will place leash/toy in a basket and the basket will be moved to the exit.
- 20. Ribbons will be self-serve. Please sanitize your hands before touching the ribbon container.
- 21. We will be following the Travel Guidelines as issued by the PA Department of Health. Current guidelines can be found by clicking the following link https://www.health.pa.gov/topics/disease/coronavirus/Pages/Travelers.aspx
- 22. Failure to abide by these protocols will be grounds for immediate dismissal.
