Checking in

You do not need to check in unless you need to be measured. **All competitors in each class must check in at the gate** by checking off their name on the call sheet. If you do not check in, the class will not wait for you. Please only check in for the class being walked. Please remember it is your responsibility to be ready at the ring for your run.

Measuring Dogs

All dogs jumping below the 22 inch Regular height, or the 20 inch Select height must have a UKI measurement, if you have not yet had one. Dogs competing above those heights do not need to be measured. If you have an actual measurement from another organization (such as AKC/USDAA), and wish to use this measurement, please bring your card to the measurer for documentation. The card will need to state the dog's exact height or we are unable to use that to verify your measurement

Changing Handlers

Competitors are required to inform the trial secretary of any handler change. Please do so in a timely manner.

Trial Site Information

Orchard Hills is located on private property and is NOT open to the public outside of trial hours. DO NOT arrive at the trial site prior to stated times. Waiting in the driveway or on Church Street is not allowed. If you find yourself arriving early, there is a Turkey Hill North on 100 and a Render's and Dunkin Donuts South on 100.

Not for Competition Runs

You may turn any run into a NFC run, but must declare this right before entering the ring. You may use a non audible toy (NO clickers). You may use this time for any type of training, as long as you are not abusive to your dog. The handler may use the SCT to train any piece of equipment multiple times. If a handler chooses to train their start line, the time will be started once the handler begins to walk back towards their dog once they have left him. You MUST leave the ring immediately once time is up.

KEYSTONE AGILITY CLUB COVID-19 COMPETITION EVENT PROTOCOL

1. If you believe you have COVID-19 or have been exposed to COVID-19 and you are not fully vaccinated, please stay home.
2. All exhibitors are required to sign our Online COVID-19 Waiver/Protocol Agreement Form prior to the date of the trial. Covid Vaccination Link
3. If you are not vaccinated please consider wearing a mask, when social distancing is not possible.
4. There is no crating inside the Green building. Crating in the Red building will be available for an additional fee of \$5.00 per day.
5. Warm up jump will be located outside.
6. Running orders, courses and scores will be posted online: a. UKI: www.k9trialsservices.com b. USDAA: www.dognutmom.com
7. Hand sanitizer and disinfectant will be available, but it is highly recommended that exhibitors bring their own.
8. Walkthroughs may be limited. Please maintain a six-foot distance during all walk throughs.
9. Upon entering the ring, leashes will be placed in a basket and the basket will be moved to the exit.
10. Ribbons will be self-serve. Social distancing is required.
11. Failure to abide by these protocols will be grounds for immediate dismissal and no refund.
