Green Building will take precedence for conflicts. We will fit you in the Red Building/Speedstakes as needed.

#### **Mask Protocol**

Masks are optional at all times.

### **Running Order**

The running order is attached. This is only for the purpose of checking your entry. Running order for Masters Jumping will be determined by the results of Masters Agility. The final running order will be posted on the gate sheets.

### **Changing Handlers**

If changing handlers, please let me know so that the results are correct.

### **Checking In**

While UKI does not require strict running order within your jump height, other than in Masters Series, KineticDog will be running dogs in order according to the gate sheet since this is a small, one-ring trial.

### **Measuring Dogs**

Measuring will take place near the check-in table prior to the first class each day. All dogs jumping below the 22 inch Regular height or the 20 inch Select height must have a UKI measurement, if you have not yet had one. Dogs competing above those heights do not need to be measured. **If you have an actual measurement from another organization (such as AKC/USDAA), and wish to use this measurement, please bring your card to the measurer for documentation. The card will need to state the dog's exact height or we are unable to use that to verify your measurement**

### **Parking/Crating**

You may crate in either the red building or the green building. In addition, you may work out of your cars or bring a shade tent. All parking is first come first served. Parking is in 2 areas; the first area is front of the red building 3 rows will fit here. There is no parking in front of these 3 rows or in front of the sheep pens. You may also park to the side of the green building in the old outdoor ring.

### **Site Information**

Orchard Hills is located on private property and is NOT open to the public outside of trial hours. DO NOT arrive at the trial site prior to stated times. Waiting in the driveway or on Church Street is not allowed. If you find yourself arriving early, there is a Turkey Hill North on 100 and a Renda's and Dunkin Donuts South on 100.

Music will be played during walkthroughs and lightly during running of classes.

### **Food**

There will not be a food vendor for lunch. Please bring your own.

### **Helpers**

This will be a two ring trial and helpers are not only appreciated but are necessary to conduct a smooth running show. Please see us if you are able to help.

### **Course Maps and Real Time Results**

We will not be providing Course Maps. Course maps will be posted each morning online.

### **Online Results**

All clear round/ qualifying results will be available to view within 2 weeks of the trial. You will be able to log on to your account and see results that were clear rounds, gaining Level points

## Not for Competition Runs

You may turn any run into a NFC run, but **must declare this right before entering the ring.** You may use a **non audible toy** (NO clickers). You may use this time for any type of training, as long as you are not abusive to your dog. The handler may use the SCT to train any piece of equipment multiple times. If a handler chooses to train their start line, the time will be started once the handler begins to walk back towards their dog once they have left him. You **MUST** leave the ring immediately once time is up.

We will NOT be offering an NFC Food Reward Area.

Route 100 (Pottstown Pike) Closure Scheduled Next Weekend for Railroad Improvement in Pottstown Borough

King of Prussia, PA – Route 100 (Pottstown Pike) is scheduled to close between Shoemaker Road and Manatawny Street in Pottstown Borough, beginning at 9:00 PM Friday, November 9, through 6:00 AM Monday, November 12, for railroad improvements related to a \$13.3 million project to improve safety and traffic flow along key corridors in Pottstown Borough and Lower Pottsgrove Township, Montgomery County and North Coventry Township, Chester County, the Pennsylvania Department of Transportation (PennDOT) announced today.

During the 24-hour per day closure , Route 100 (Pottstown Pike) passenger vehicles will be detoured over Route 663 (King Street), Manatawny Street and State Street. Trucks will be directed to use Route 724 (Schuylkill Road), Hanover Street, Farmington Avenue, Wilson Street and State Street.

Motorists are advised to allow extra time when traveling near the work area because slowdowns will occur. The contractor's schedule is dependent on the weather.

- from Allentown, Harrisburg, Central New Jersey:

78 east or west to Allentown exit, Cedar Crest Blvd. South to Emmaus past hospital, at "T" turn right (Chestnut Street or Rt. 29 S) continue south on Rt.29 to Rt.100 South, continue to Hereford - 4 more miles to Bally. Middle of town is Longacre Electric (orange and blue sign) turn onto N. Church Street; go up hill approx. 1 mile. See pond on left side, turn left onto Bella Vista Lane. Continue on dirt drive until you see the agility fields.

- From Pa. Turnpike:

NE extension to Quakertown exit bear right onto Rt. 663 S. (heading to Pennsburg) In Pennsburg, at Wendy's Flowers, intersection of Rt. 29, turn right onto Rt. 29 N to town of Hereford (Turkey Hill convenience store and light). Turn left onto Rt.100 S to town of Bally (continue as above).

- From Philadelphia:

Rt. 422 or 73 to Rt. 100 N to town of Bally. At Longacre's Electric, turn left onto North Church Street. Go approx. 1 mile; on left you'll see a pond, turn left on Bella Vista Lane; follow till you see agility fields.
