Speedstakes 1 then 2 - Novice & Beginners, Champion & Senior  
Jumping - Novice & Beginners, Champion & Senior  
Snooker - Novice & Beginners, Champion & Senior  
Agility - Novice & Beginners, Champion & Senior

### COVID-19 Procedures

### Checking in

You need to check in if you need to be measured and/or owe entry fees. All entry fees must be paid prior to running your first class. Failure to pay prior to running may jeopardize your results. **All competitors in each class must check in at the gate at the start line.** If you do not check in, the class will not wait for you. Please remember it is your responsibility to be ready at the ring for your run. **We will NOT be using Agility Gate for this trial. Please check in for each class the old-fashioned way before each walkthrough.**



### **Measuring Dogs**

All dogs jumping below the 22-inch Regular height, or the 20 inch Select height must have a UKI measurement, if they have not yet had one. Dogs competing above those heights do not need to be measured. If you have an actual measurement from another organization (such as AKC/USDAA), and wish to use this measurement, please bring your card to the measurer for documentation. The card will need to state the dog's exact height, or we are unable to use that to verify your measurement.

### **Running Order & Course Maps**

A preliminary running order will be posted online by Thursday afternoon at <https://k9trialservices.com>. Please note, this is for informational purposes only and may change without notice. Paper course copies will not be available on site. The course maps will be posted online each morning 3 hours prior to trial site opening (Master Series maps will be posted at site opening time). ### **Class Results**

Class results will be printed & available after a class is scored on the self-serve ribbon table.

### **Food Services**

Sorry, there will be no food provided on site, other than worker's hospitality. Please plan accordingly.

### **Helpers**

Keystone depends on volunteers to make this a great trial. There will be a sign-up board on site for you to select the jobs/classes you wish to work. We thank you in advance for your help!

### **Crating**

Crating will be available in the building for this trial and will be on a first come first serve basis.

### **Online Results**

All clear round/ qualifying results will be available to view within 2 weeks of the trial. You will be able to log on to your account and see results that were clear rounds, gaining Level points.

### **Changing Handlers**

Competitors are required to inform Kathleen Schaefer of any handler change. Please do so in a timely manner.

### **Trial Site Information**

Orchard Hills is located on private property and is NOT open to the public outside of trial hours. DO NOT arrive at the trial site prior to stated times. Waiting in the driveway or on Church Street is not allowed. If you find yourself arriving early, there is a Turkey Hill & a Wawa North on 100 and a Redner's and Dunkin Donuts South on 100.

### **Not for Competition Runs**

You may turn any run into an NFC run but must declare this right before entering the ring. You may use a non-audible toy (NO clickers). You may use this time for any type of training, if you are not abusive to your dog. The handler may use the SCT to train any piece of equipment multiple times. If a handler chooses to train their start line, the time will be started once the handler begins to walk back towards their dog once they have left him. You MUST leave the ring immediately once time is up.

**Bitches in Season:** Bitches in Season may run at this trial. To be able to run a BIS, you must immediately tell the trial secretary. The trial secretary will mark BIS on the running orders. Any BIS will run in order, regardless of height. If the dog is not wearing BIS pants, they will start on a mat provided by the handler. It is the handler's responsibility to ensure the mat is available for their runs. The handler/owner acknowledges the inherent risk of running a dog on an agility course with BIS pants on and assumes all risk by doing so.
