### **Checking in**

You do not need to check in unless you need to be measured and/or owe entry fees. All entry fees must be paid prior to running your first class. Failure to pay prior to running may jeopardize your results. All competitors in each class must check in with the gate by using the Agility Gate App. The Exhibitor code is **0101**. If you do not check in, the class will not wait for you. Please remember it is your responsibility to be ready at the ring for your run.

### **Measuring Dogs**

Measuring will take place near the check-in table prior to the first class. All dogs jumping below the 22 inch Regular height or the 20 inch Select height must have a UKI measurement. The 10th Edition of the rule book has new regulations on measuring. Please see page 26, section 4.5 on Measuring Dogs.

### **Running Order & Course Maps**

### **Changing Handlers**

Competitors are required to inform the trial secretary of any handler change. Please do so in a timely manner.

### **Trial Site Information**

Orchard Hills is located on private property and is NOT open to the public outside of trial hours. DO NOT arrive at the trial site prior to stated times. Waiting in the driveway or on Church Street is not allowed. If you find yourself arriving early, there is a Turkey Hill & a Wawa North on 100 and a Redner's and Dunkin Donuts South on 100.

### **Not for Competition Runs**

You may turn any run into an NFC run but must declare this right before entering the ring. You may use a non-audible toy (NO clickers). You may use this time for any type of training, if you are not abusive to your dog. The handler may use the SCT to train any piece of equipment multiple times. If a handler chooses to train their start line, the time will be started once the handler begins to walk back towards their dog once they have left him. You MUST leave the ring immediately once time is up.
