## Checking in

You do not need to check in unless you need to be measured and/or owe entry fees. All entry fees must be paid prior to running your first class. Failure to pay prior to running may jeopardize your results. All competitors in each class must check in with the gate by using the Agility Gate App. The Exhibitor code is *0712*. If you do not check in, the class will not wait for you. Please remember it is your responsibility to be ready at the ring for your run.

**Measuring Dogs** - Please ensure you understand the new criteria regarding dogs being measured. <u>UKI Rule Book edition 10</u> If a dog is under 3 and newly registered, a temporary measure or proof of the dog's height must be done by the dog's 3<sup>rd</sup> trial. A permanent measure must be obtained by a UKI official measurer between 12-18 months after the dog's first/ temporary measure. Any registered dog that only has a temporary measure, must follow the above rule. If a newly registered dog is over 3, they must obtain a measure by an official UKI measurer by their 3<sup>rd</sup> trial and this measurement will be permanent.

## **Running Order & Course Maps**

A preliminary running order will be posted online by Thursday afternoon at <a href="https://k9trialservices.com">https://k9trialservices.com</a>. Please note, this is for informational purposes only and may change without notice. The official run order will be in Agility Gate by the morning of the show Paper course copies will not be available on site. The course maps will be posted online each morning 3 hours prior to trial site opening (Master Series maps will be posted at site opening time). #### **Class Results & Ribbons**

#### Helpers

Keystone depends on volunteers to make this a great trial. There will be a sign-up board on site for you to select the jobs/classes you wish to work. We thank you in advance for your help!

#### Crating

Crating in your vehicle is highly encouraged as parking is close to the ring. Limited crating will be available in the building for this trial and will be on a first come first serve basis.

#### **Results Posted on UKI**

All clear round/ qualifying results will be available to view on your UKI account within 2 weeks of the trial. You will be able to log on to your account and see results that were clear rounds, gaining Level points.

## **Changing Handlers**

Competitors are required to inform the trial secretary of any handler change. Please do so in a timely manner.

#### **Trial Site Information**

Orchard Hills is located on private property and is NOT open to the public outside of trial hours. DO NOT arrive at the trial site prior to stated times. Waiting in the driveway or on Church Street is not allowed. If you find yourself arriving early, there is a Turkey Hill & a Wawa North on 100 and a Redner's and Dunkin Donuts South on 100.

#### Not for Competition Runs

You may turn any run into an NFC run but must declare this right before entering the ring. You may use a non-audible toy (NO clickers). You may use this time for any type of training, if you are not abusive to your dog. The handler may use the SCT to train any piece of equipment multiple times. If a handler chooses to train their start line, the time will be started once the handler begins to walk back towards their dog once they have left him. You MUST leave the ring immediately once time is up.
